# **Notes from the President:**

# Work Day project for May:

The February and April work parties plus all those days in-between has produced many board feet of lumber to be used in construction projects. Many thanks to Tim Neel and those that helped him in the milling task of converting the logs into boards. There are still a number of logs that need to be moved to the new mill yard. Also, there are still a number of damaged trees that need to be cut into saw logs. Tim has moved his mill but will return when we have the new mill yard stocked with logs. Anyone that wants work day credit can contact Jon Yagla to see when he will be available with his tractor to move the logs.

There are still a large number of downed trees to be cut into saw logs. This will be a project at the May work party. It will require the three members for each team: 1 member with a chain saw; two members with a 16 foot tape measure and one ax to mark the logs;

#### **GENERAL MAINTENANCE:**

Weed Whackers and/or push lawn mowers to trim the slope in front of the rifle/pistol ranges; around the target frames; camp grounds; shotgun range and picnic area;

Pruning shears to cut back overhanging tree branches along the road and side lines on the ranges;

Pickup Truck with King George county sticker to make the usual trash run to the dump;

Saws, hammers, etc to rebuild the damage target covers on the archery range:

#### SAFETY NOTICE REMINDER:

MEMBERS - YOU MUST PLACE TARGETS SO THAT YOU ARE SHOOTING IN A STRAIGHT LINE TO THE TARGET AND THE BULLETS ARE IMPACTING IN THE BERM. When you are firing at an angle to the target your bullets are not impacting the designed berm. The bullets may exit the range across the road or the right side of the range.

Shooters are remaining on the firing line when a cease fire is called and the range is cold so people could go down range and put up targets. When the firing line is cold EVERYONE MUST MOVE behind the firing line so the Safety Officer has a clear view up and down the firing line. Thank you for following these two safety rules.

NOTICE: ANYONE WHO USES ANY TYPE OF METAL OR WOOD TARGET MATERIAL:

IT IS YOUR RESPONSIBILITY TO REMOVE THE TARGET MATERIAL FROM THE RANGE. THE TRACTOR TIRES ARE NO MATCH FOR THIS MATERIAL. PERSISTENCE IN LEAVING ANY TYPE OF METAL OR WOOD TARGETING MATERIAL WILL NECESSITATE A RULING ON WHAT TYPE OF MATERIAL CAN BE USED ON THE RANGE.

I wish to thank all the club members that are cleaning up the range after they finish shooting. It sure makes the range look better and cutting the range a lot less time consuming.

#### SPECIAL NOTICE:

We had some visitors at the range sometime between late Saturday, April 17 and early Monday April 19. He/she/they spread roofing nails at the entrance gate and did some vandalism around the range. It is important to document these events when they occur. I am requesting each of you to take the time to record the day, time, and exactly what you find when you see this. If you have a cell phone if would be very beneficial to call the King George Sheriff's office and report the event. It would also be appropriate to call the Sheriff's office and have a deputy come to the range to document the vandalism. The only way to stop this action is to take action. Thank You.
